**Respirator Fitting Instructions**

OSHA Standard 29 CFR 1910.134 (e)(5) requires that the wearer be fit tested.  
The Saccharin Qualitative Fit Test is recommended for this respirator.



1. Hold the respirator in hand with the nosepiece at your fingertips, allowing the headbands to hang freely below your hand. Press the respirator firmly against your face with the nosepiece on the bridge of your nose.



2. Stretch and position the top band high on the back of your head. Stretch the bottom band over the head and position below your ears. Using both hands, mold the metal nosepiece to the shape of your nose.



3. To test fit, cup both hands over the respirator and exhale vigorously. If air leaks, tighten nosepiece or reposition straps for a better fit. Remember, careful observation of these fitting instructions is an important step in safe respirator use.

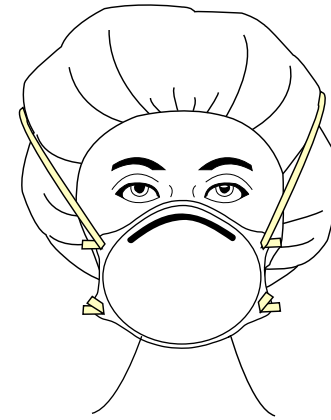
